A-DAY REGISTRATION - for examinees who have previously tested and have letter of scores from the Texas education agency (TEA) between 1/1/02 to present.

"A" day registrations are held between the hours of 11am and 6pm. Have your picture ID and Social Security card, letter of scores, and the teachers re-test letter if applicable.

Exam Fee: \$12 Re-test Fee: \$15

B-DAY REGISTRATION - for *new examinees* who have never attempted the GED Exams since January 1, 2002 to present:

NEW REQUIREMENTS:

Step 1:

All new examinees must complete the Demographic Form on-line prior to entering a testing center. You may do this from any computer that has internet access. You will be provided a UT EID and password upon completion. NISD CODE 1720

Step 2:

Call 397-8969 to schedule an appointment for registration/orientation taking place on a "B" day. Have your UT EID and password for verification of on-line form completion.

ITEMS TO BRING TO REGISTRATION/ ORIENTATION:

(Two forms of government Issued Identification (#s 2 & 5))

1. UT EID and Password.
2. **Government issued Picture Identification.** (can not be expired). (Example: TX ID, TX DL, Military ID, Passport).
3. Proof of address if the address on the Picture ID is incorrect or does not exist. (Example: A bill in your name).
4. Be a resident of Texas
5. Social Security Card
6. Cash or money order only.
7. **17 years old: Must have in addition to the above items:**
A) A copy of your withdrawal form from the last school attended.
B) A parent or guardian must accompany you during registration. (Identification/legal guardianship papers required).
8. **16 years old: Must have in addition to all the above mentioned items:**
C) Original court order (as required by Section 45.054 of the Code of criminal Procedure).

It is recommended that examinees take the official practice test (OPT). You may contact Adult Education Department @ 397-8109 to get more information or log on to: <http://www.gedpractice.com>
