### **District Insurance**

Please commit to one of the following security and maintenance options by placing your initial in the appropriate box.

\$60 Payment  **I ACCEPT DISTRICT INSURANCE:** I accept the purchase of District insurance. I choose to pay the \$15 annual maintenance fee AND the \$45 annual insurance premium. This \$60 is NOT refundable, and I understand that I am responsible for up to the \$100 deductible for each instance the insurance is used. I understand that I must renew this insurance EACH year.

\$15 Payment & \$200 Deposit  **I DO NOT ACCEPT DISTRICT INSURANCE:** I am providing my own insurance. I know that this places the responsibility on me to either find insurance that will cover the equipment OR I will take full responsibility for the full cost of the laptop (if lost) or cost of repair (if damaged). If using personal insurance, proof must be provided.

A table of estimated pricing for a variety of repairs is included in the Laptop Handbook for your reference.

### **Acceptable Use Policy Agreement**

I have read the Student and Parent Agreement for the Acceptable Use of the District's Electronic Communications System in the Student-Parent Handbook, District policies and the Administrative Regulation, and the Student-Parent Laptop Handbook. I understand that the Internet is a worldwide group of hundreds of thousands of computer networks. I agree that the Northside Independent School District does not control the content of these Internet networks.

**I understand if my child violates the Acceptable Use Policy, his/her access privilege to the District Internet may be revoked and is subject to disciplinary action that may include the revocation of enrollment at Business Careers High School.**

The Northside ISD has my permission to give Internet access to my child. I understand that my child will maintain this privilege as long as the procedures described in the Administrative Regulation for Acceptable Use are followed. Consequences are outlined in the Code of Student Conduct in the Student-Parent Handbook.

### **Terms of Agreement**

Northside ISD grants permission to the student to have limited use of the laptop described in this agreement. The student is responsible at all times for the care and appropriate use of his/her laptop. The laptop remains the property of the Northside ISD and cannot be loaned, sold, bartered, traded, leased, rented or given to any other person or persons without the express, written consent of Northside ISD. Permission granted to the student ceases on the LAST CALENDAR DAY OF THIS CURRENT SCHOOL YEAR (unless terminated earlier by Northside ISD) and failure to return the said laptop on or before that date to the campus Principal or designee will result in criminal charges being sought against the student and/or person who has the laptop. Northside ISD reserves the right at any time to demand return of the laptop forthwith.
