

CONSTITUTION
of
The
Choir Boosters of John Jay High School
San Antonio Texas

ARTICLE I - NAME

The (organization or corporation) shall be known as: The Choir Boosters of John Jay high school, hereinafter referred to as "Choir booster(s) or booster(s)" (or "organization" or "Corporation") a member of a non-profit organization incorporated under the laws of the State of Texas.

ARTICLE II - STATEMENT OF POLICY

SECTION 1 - it shall be the policy of the choir booster so to conduct its activities that the physical and moral welfare of the young people for whose benefit it is organized shall remain paramount and all matters of policy shall be determined on that basis.

SECTION 2 - no person who is a member of or who is employed by or who is in any way connected with the choir boosters shall receive any personal financial benefit therefore beyond the reasonable value of the service in carrying out the purpose for which the booster has been organized.

SECTION 3 - in order to secure suitable and adequate financial backing to carry out the purpose of the choir booster, it shall be the policy of the boosters to permit only such sponsorship as is consistent with the purpose for which the choir booster is organized and to select sponsors who are interested in the choir boosters solely or principally as a means of contributing to the welfare of young people.

SECTION 4 - it shall be the policy of the choir boosters to prohibit any direct advertising of alcoholic beverages or tobacco products in connection with the choir boosters of John Jay or any of its programs.

ARTICLE III - PURPOSE

SECTION 1 - the purpose of the choir booster shall be to organized exclusively to support the John Jay choir. Conduct fundraising efforts to secure suitable and adequate financial backing.

ARTICLE IV - MEMBERSHIP

SECTION 1 - volunteers adult leaders, parents or guardians of the John Jay student choirs, sponsors and other contributors, interested adults shall be eligible for membership. Membership may include parents of any current or past members, elected officers and members of the board of directors, committee people, and others.

ARTICLE V - BOARD OF DIRECTORS

SECTION 1 - the board of directors shall be those persons elected by the members of the choir boosters at the annual meeting for the terms and/or in the manner provided for in the Bylaws of the choir booster.

SECTION 2 - in recognition of the general powers of the board of directors exercised by virtue of the office, they shall have the power: to purchase or otherwise acquire for the booster property, right or privilege which the choir booster is authorized to acquire by the booster membership, at such price or consideration and upon such terms as the board of directors may deem expedient and as is approved by vote of the booster membership; to appoint or remove or suspend subordinate agents or volunteers and to determine their duties; to determine who shall be authorized, on behalf of the choir booster, to sign bills, notices, receipts, acceptances, endorsements, checks, release, contracts, and any other instruments; to delegate any of the powers of the board of directors to any standing committee, special committee or any officer or agent of the choir boosters, with any powers as the board of directors may see fit to grant and to generally do all such lawful acts and take action as may be necessary and proper.

ARTICLE VI - OFFICERS

SECTION 1 - the officers of the choir boosters of John Jay shall consist of a President, Vice President, Secretary, and Treasurer.

ARTICLE VII - GOVERNMENT

SECTION 1 - the government of the choir booster shall be under the direct supervision of the officers and board of directors.

ARTICLE VIII - BYLAWS

SECTION 1 - any Bylaws, not consistent with this Constitution, embodying additional provision for the government of the Corporation, shall be adopted and may be amended by the membership of the choir booster.

ARTICLE IX - AMENDMENTS

SECTION 1 - this Constitution may be amended only by a majority vote of the choir boosters membership at a annual meeting of the boosters membership, or a special meeting of the boosters membership called for that purpose.
