2. Project Graduation, the event, is a drug free, alcohol free, and smoke free environment. I will not be admitted if it is suspected that I have already consumed drugs or alcohol. My use of these products during the celebration will result in immediate removal and a phone call will be made to my parents/guardian. A police officer will be on site to deal with the inappropriate behavior or violations of the law.
3. I will respect the event site and do no malicious damage. I understand that in the event of my inappropriate behavior, I may be asked to leave the party and agree that if asked to leave, I will do so. Any violation will be dealt with in accordance with the law. **My parent/guardian will be contacted to pick me up.**
4. Once registration is paid, money is not refundable. I understand that once I check in at Stevens High School on June 8, 2010 I CANNOT leave.
5. I understand that transportation will be provided to and from Stevens to the event site. Transportation will be provided back to Stevens to arrive at approximately 6:00 AM, June 9th.
