Technology Management Services

Academic Technology Services
Responsible for state technology curriculum requirements (TEKS for Technology Applications K-12), integration of technology into foundation and enrichment curricula, and technology support for Curriculum and Instruction.

Library & Textbook Services
Provides support & leadership for campus librarians and library programs by delivering professional development, online circulation and library catalog, centralized cataloging and provides for the ordering and distribution of all state adopted textbooks.

Integrated Information Services
Responsible for business and student data collection, analysis, usage and reporting required to meet federal, state, and local legal requirements as well as end user needs.

Integrated Infrastructure Services
Responsible for the design, management and operation of stable and robust instructional/administrative systems which provide fully integrated voice, video, and data to meet federal, state and local legal requirements, and bring information to the user's desktop.
