This meeting is to discuss the District's options of either continuing with a fully insured health insurance plan or possibly exploring the option of moving to a self-funded health insurance plan. The pros and cons of both plans will be discussed, with the guidance and expert opinion of the District's insurance consultant, McGriff. Factual data relating to the District's last five years of health insurance usage will be utilized to help make a decision that is best for both NISD and our employees.

5Year Claim vs Premium Look-back

- NorthsideISD's annual trend has run below the national trend every year since 2018.
- On average, since 2018, NorthsideISD's average medical and pharmacy trend combined 4.6% per year. The national average is between 7%- 9%.
- For 2023, the trend factor used for renewal was a combined trend factor of 9.7%.
