Discussion: A. 2023-2024 Compensation Discussion

Administration will discuss the development of the fiscal year 2023-24 budget with regard to a possible general pay increase (GPI) to be included in the proposed budget.

District staff presented to Trustees a general compensation proposal for the 2023-2024 school year. The proposal equates to an approximate 3% pay increase for all staff and would increase the general fund expenditure budget by approximately \$22.6 million. Trustees also heard a retention payment proposal developed to help retain existing employees and recruit new hires. The retention proposal would be paid using Elementary and Secondary School Emergency Relief (ESSER) funds to employees hired on or before Sept. 1, 2023. Payment amounts would be differentiated by employee categories. Both the compensation and retention proposals were for discussion only and is expected to be considered by the Board at the Called Board meeting on June 13
