- Support and Capacity Building to include strategic staffing, data-driven instruction, targeted professional learning, and principal coaching.
- Performance Management to include regular performance reviews, enhanced classroom walkthroughs to ensure fidelity, and supervisor visits to provide targeted instructional support

#### 8. Administration

A. First Reading of DGB (LOCAL) Policy

The Government and Policy committee, chaired by Ms. Zapata, met on October 22, 2025. A request was made by Ms. Zapata to place DGB (Local) on the committee agenda for discussion. During the committee meeting, it was determined that the policy change should go to the board for full discussion in the next Regular Board Meeting. This item is for discussion and first reading.

#### Citizens to be Heard:

Patty Cantu-24 years in education

Does not want unions and other organizations allow on campus during school hours.

- Why does someone have to enter a building to have personal meetings during school hours?
  - They can come once school is over.
- Priority should be the safety of our kids and limiting visitors
- AFT refused to work together on writing Legislative Properties when asked to collaborate, and talk badly about people and other organizations.

- They do not want to be a team; they want to be the ONLY team.
- They say **WE**, but don't mean it.
  - o Who is WE? WE means only AFT.

Board goal: Let's work to revise the legal aspect to better align with the campus's practices.

## B. Campus Safety Update

Type: Information

#### **Physical Security & Operations**

Door Monitoring Alarms (DMA): Fully installed and currently being programmed to meet specific campus needs.

- Secure Entries: Every building has either a secure lobby or staff present at the entry.
- High School Lunches: Plan to close high school lunches, except students who have earned CCMR status.
- School Flasher Lights (John Jay & Holmes High Schools): Request submitted to the City of San Antonio to amend Ordinance 99654 to activate school zone flasher lights during high school lunch periods (11:45 a.m. to 2:45 p.m.).
- Crossing Guard Staffing: Reviewing staffing, focusing only on access points directly adjacent to school grounds.

Hazardous Route Determination

- District Law Enforcement, Risk Management, and Transportation will work collaboratively to create a transparent process for determining hazardous routes. This process will include hazardous routes due to violent crime.
- Violent Crime Definition (Used for Safe Walking): The team has identified the following crimes as affecting safe walking: ○

## **Aggravated Assault**

- Homicide/Manslaughter
- Kidnapping/Human Trafficking
- Robbery-Individual
- Sexual Assault
- Weapons Violation
- Challenge: No state or national standard found for quantifying "high-crime" or "unsafe" walking zones (e.g., number of incidents over a timeframe). This determination is left to individual jurisdictions.
- SAPD/UTSA Hotspot Data: The Violent Crime Reduction Plan identifies "hot spots" based on concentrated robberies, aggravated assaults, and homicides over the past 12 months and the most recent 60 days.

Key Next Steps for Determining Hazardous Routes based on Violent Crimes 1. Formally propose a local, quantified standard for a "high-crime" area at a board workshop in Spring of 2026. 2. Expedite the finalization of the transparent "key work process" document with the transportation department to incorporate the new standard. 3. Finalize and announce School Lunch Closures by January 2026 for the 26-27 school year. 4. Awaiting a response from the City on the flashing lights request for John Jay and Holmes. 5. Continue to monitor the need for additional crossing guards that are directly supported by NISD and the City of San Antonio.

## 9. Superintendent

A. Bexar County Appraisal District Board of Directors Appointment Type: Discussion and Action

Northside ISD Board nominated Gerald Lopez and Becky Ruiz to the Bexar County Appraisal District. NISD along with other taxing entities nominated a total of seven candidates. Northside ISD has 921 of 5,000 total votes. The NISD vote to apply the 921 votes must be made by board resolution.

The District will be receiving new and updated information from Bexar CAD regarding the votes. The Board will bring this agenda item to the Dec. 9 Board Meeting.
