General Fund - Child Nutrition Fund - Debt Service Fund

Adopted by the Northside ISD Board of Trustees on
August 11, 2026

The following budgets have been prepared in accordance with the Texas Education Code §44.002. Requirements under §44.004 of the same code related to the *Notice of Budget and Tax Rate* have also been adhered to in the preparation of the adopted 2026-2027 fiscal year budget. The three budgets required to be adopted by the Northside ISD Board of Trustees are presented for your review and consideration for approval.

General Fund

The General Fund is the largest of the three funds to be considered for adoption and accounts for the majority of instructional and operational activities of the district. Total General Fund revenues are projected to be \$1.07 billion, with local revenue comprising 50% of total General Fund revenue and state revenue comprising 49%. Federal revenue accounts for 1% of budgeted General Fund revenue. Local taxes will be generated with an adopted maintenance and operations (M&O) tax rate of \$0.6994, comprised of an assigned¹ Tier one tax rate of \$0.6194 plus \$0.08 enrichment pennies, also referred to as “golden” pennies. The Board has previously adopted five of the golden pennies and, in a future agenda item, will be asked to adopt the remaining three golden pennies and call for a Voter Approval Tax Rate Election (VATRE).² The three additional “golden” pennies are expected to generate approximately \$21.5 million in local tax revenue and approximately \$25 million in state revenue if approved by voters. State revenues continue to be formulaic and are predicated primarily on an estimated average daily attendance (ADA) of 88,150 students.³

Total budgeted expenditures in the General Fund are \$1.09 billion, with 82% of those expenditures allocated to direct instruction, instructional support and school leadership, and student support. These total expenditures reflect a \$32.5 million increase in employee compensation, as approved by the board and contingent on passage of the VATRE, and \$33.2 million in budgetary savings achieved through district-wide staffing reductions.

The net result of operations for the General Fund is a deficit of \$17.9 million. This deficit does not take into account any unexpended budgeted funds, which are normal and customary in any budget.

Child Nutrition Fund

The Child Nutrition Fund accounts for the various programs that provide meals to Northside ISD students.

Revenue for the Child Nutrition Fund will be primarily federal, through reimbursements paid for every meal served. Federal revenue accounts for 84% of the total \$60.5 million in expected revenue. Expenditures are budgeted at \$60.5 million, resulting in a balanced budget for the Child Nutrition Fund. Like the General Fund, the Child Nutrition budget does not take into account any unexpended budgeted funds.

Debt Service Fund

The final fund to consider for approval is the Debt Service Fund, which accounts for taxes collected to repay bonded debt. In addition to the scheduled bond principal and interest payments in 2026-27, the district has planned a cash defeasance payment of principal in an amount of no less than \$84 million, bringing the total budgeted debt service expenditures to \$263.45 million. Defeasance is the accelerated payment of bond principal, thus both reducing the amount of outstanding principal and lowering the amount of interest paid by NISD taxpayers.

Revenues to cover the defeasance and scheduled payments will be generated by applying an interest and sinking (I&S) tax rate of \$0.3355 to taxable values. The adopted I&S tax rate will be the sixteenth consecutive year the I&S rate has been \$0.3355. Total budgeted revenue for the Debt Service Fund is \$262.6 million, resulting in a deficit of \$887,022.

Taxable Values

Bexar, Bandera, and Medina counties have certified their 2026 taxable values. The district calculates a separate taxable value for budgeting purposes that assumes values under appraisal review board (ARB), on the date of certification, will come onto the rolls at lower values. Estimated taxable value for tax year 2026 is \$72,411,637,498, which is a 2.4% decrease from the prior year⁴. If approved by the board, the district will apply the adopted total tax rate of \$1.0349 to this value to fund operations in the General Fund (along with state and federal dollars) and collect taxes to repay bonded debt.

If the board calls for the VATRE and the VATRE does not pass by Northside ISD voters, district staff will be required to return to the board to adopt a lower tax rate that does not include the three additional pennies in the maintenance and operations portion of the tax rate. District staff would also bring forward an amendment to the general fund budget.

The three budgets to be considered for adoption begin on the next page.

GENERAL INFORMATION: Tax Code Section 26.04(c) requires an officer or employee designated by the governing body to calculate the no-new-revenue tax rate and voter-approval tax rate for the taxing unit. These tax rates are expressed in dollars per \$100 of taxable value calculated. The calculation process starts after the chief appraiser delivers to the taxing unit the certified appraisal roll or certified estimate of value and the estimated values of properties under protest. The designated officer or employee shall submit the rates to the governing body by August 7 or as soon thereafter as practicable. Tax Code Section 26.04(e-1) does not require school districts to certify tax rate calculations or comply with certain Tax Code notice requirements. School districts are required to provide notice regarding tax rate calculations pursuant to Education Code Chapter 44.

This worksheet is for **school districts without Tax Code Chapter 313 or Government Code Chapter 403, Subchapter T, Texas Jobs, Energy, Technology, and Innovation Act (JETI) agreements only**. School districts that have a Chapter 313 or JETI agreement should use Comptroller Form 50-884 *Tax Rate Calculation Worksheet, School Districts with Chapter 313 and JETI Agreements*.

Water districts as defined under Water Code Section 49.001(1) do not use this form. Use Comptroller Form 50-858 *Water District Voter-Approval Tax Rate Worksheet for Low Tax Rate and Developing Districts* or Comptroller Form 50-860 *Developed Water District Voter-Approval Tax Rate Worksheet*.

SECTION 1: No-New-Revenue Tax Rate

The no-new-revenue (NNR) tax rate enables the public to evaluate the relationship between taxes for the prior year and for the current year based on a tax rate that would produce the same amount of revenue if applied to the same properties that are taxed in both years (no new taxes). When appraisal values increase, the NNR tax rate should decrease.

Voter Approval Tax Rate

The voter-approval tax rate is the highest tax rate that a taxing unit may adopt without holding an election to seek voter approval of the rate. Most school districts calculate a voter-approval tax rate that is split into three separate rates.²¹

SECTION 2: Maximum Compressed, Enrichment and Debt Tax Rate Worksheet

This section calculates three components of the voter-approval tax rate:

- Maximum Compressed Tax Rate (MCR):** A district's maximum compressed tax rate is defined as the tax rate for the current tax year per \$100 of valuation of taxable property at which the district must levy a maintenance and operations tax to receive the full amount of the tier one allotment.²²
- Enrichment Tax Rate:**²³ A district's enrichment tax rate is defined as any tax effort in excess of the district's MCR and less than \$0.17. The enrichment tax rate is divided into golden pennies and copper pennies. School districts can claim up to 8 golden pennies, not subject to compression, and 9 copper pennies which are subject to compression.²⁴
- Debt Rate:** The debt rate includes the minimum dollar amount required to be paid toward the school district's debt service for the current year.²⁵ This rate accounts for principal and interest on bonds and other debt secured by property tax revenue.

The MCR and Enrichment Tax Rate added together make up the school district's maintenance and operations (M&O) tax rate. Districts cannot increase the district's M&O tax rate to create a surplus in M&O tax revenue for the purpose of paying the district's debt service.²⁶

If a school district adopted a tax rate that exceeded its voter-approval tax rate without holding an election to respond to a disaster in the prior year, as allowed by Tax Code Section 26.042(e), the school district may not consider the amount by which it exceeded its voter-approval tax rate (disaster pennies) in the calculation this year. This adjustment will be made in Section 4 of this worksheet.

A district must complete an efficiency audit before seeking voter approval to adopt a M&O tax rate higher than the calculated M&O tax rate, hold an open meeting to discuss the results of the audit, and post the results of the audit on the district's website 30 days prior to the election.²⁷ Additionally, a school district located in an area declared a disaster by the governor may adopt a M&O tax rate higher than the calculated M&O tax rate during the two-year period following the date of the *declaration without conducting an efficiency audit*.²⁸ Districts should review information from TEA when calculating their voter-approval tax rate.

SECTION 3: Adjustment for Pollution Control

A school district may raise its rate for M&O funds used to pay for a facility, device or method for the control of air, water or land pollution. This includes any land, structure, building, installation, excavation, machinery, equipment or device that is used, constructed, acquired or installed wholly or partly to meet or exceed pollution control requirements. The school district's expenses are those necessary to meet the requirements of a permit issued by the Texas Commission on Environmental Quality (TCEQ). The school district must provide the tax assessor with a copy of the TCEQ letter of determination that states the portion of the cost of the installation for pollution control.

This section should only be completed by a school district that uses M&O funds to pay for a facility, device or method for the control of air, water or land pollution.

SECTION 4: Prior Year Disaster Tax Rate Adjustment

If a school district adopted a tax rate that exceeded its voter-approval tax rate without holding an election to respond to a disaster in the prior year, as allowed by Tax Code Section 26.042(e), the school district may not consider the amount by which it exceeded its voter-approval tax rate in the calculation this year.³⁹ As such, it must reduce its voter-approval tax rate for the current tax year.

This section applies to a school district in a disaster area that adopts a tax rate greater than its voter-approval tax rate without holding an election in the prior year, as provided for by Tax Code Section 26.042(e).
