X. Curriculum and Instruction

A. 2021-22 Calendar Revision Proposal

A proposal to provide five teacher planning time/early dismissal days to the 2021-22 calendar was presented. The days selected are on Wednesdays and are proposed for one a month starting in January 2022. On a motion by Corinne Saldana and a second by Carol Harle, the proposed calendar revision was unanimously approved.

XI. Facilities and Operations

A. Master Plan – Stevens HS CAST Teach Magnet

On a motion by M'Lissa Chumbley and a second by Corinne Saldana, the master plan for Stevens HS CAST Teach Magnet was unanimously approved as presented by Pfluger Architects.

XII. Business and Financial Services

A. Budget Amendment #1 for Fiscal Year 2021-22

Budget Amendment #1 amended only the General Fund with the Child Nutrition and Debt Service funds being included to indicate no amendments to those funds. General Fund revenue was amended to recognize various revenue sources not incorporated into the adopted budget, the majority of which is related to concession revenue. General Fund expenditures were amended to recognize a net increase of \$12 million with the majority (91%) represented by the following: Campus Carryforward - \$7,126,717 and Purchase Order Carryforward - \$3,915,630. A motion was made by Gerald Lopez and seconded by Joseph Medina to approve Budget Amendment #1 as presented. Motion carried unanimously.

B. Resolution to Cast Votes in the Election for the Board of Directors of the Bexar Appraisal District

A motion was made by Gerald Lopez and seconded by Joseph Medina to approve a resolution to cast 840 votes for Dave Gannon, 135 votes for Cheri Byrom, and 97 votes for Jon Fisher. Motion carried unanimously.

C. Resolution to Cast Votes in the Election for the Board of Directors of the Bandera Central Appraisal District

A motion was made M'Lissa Chumbley and seconded by Gerald Lopez to approve a resolution to cast 61 votes for Ernest DeWinne. Motion carried unanimously.

D. Resolution to Case Votes in the Election for the Board of Directors of the Medina County Appraisal District

A motion was made by M'Lissa Chumbley and seconded by Joseph Medina to approve a resolution to cast 27 votes each for Clay Bell and Tim Hardt and 26 votes each for Jody Jacobs, Mamie Navarro, and Cindy Segovia. Motion carried unanimously.
