#### A. Budget Review

- Option A assumes that Semester 1 total refined ADA would follow historic trends where Full Year ADA is about 99.3% of Semester 1 total refined ADA. However, attendance for the 4th six-weeks is already lower than what would have been expected had another spike in Covid not occurred. This model, although no longer realistic, would be a best-case scenario.
- Option B assumes that the 4th six weeks will average to about 84.5% followed by a gradual improvement the last two six-week periods for a full year average of 90.16%.
- Option C assumes that NISD would continue at 84% for the remainder of the school year. The full year average would be 88.31%

The recommended choice is Option B.
