As of September 1, 2021, Northside ISD began operating its own concessions at various sports facilities around the District. Previously, the Northside Booster Association ("NBA") had operated concessions utilizing primarily volunteer labor to staff concession stands. Also, in a previous agreement between the NISD and NBA, a portion of profits derived from concession sales were distributed to the primary athletic booster and band/fine arts booster clubs at NISD comprehensive high schools.

This resolution will allow the practice of sharing in profits earned from concession sales to continue. The resolution delegates to the Superintendent the authority to share in any profits earned through concessions in a manner that is deemed appropriate.

The recommended proposal is to renew Medical Insurance with United Healthcare for 2023. Plan Premiums remained the same in 2021 and 2022. The plan's utilization remains favorable. We successfully negotiated a premium increase of 5.9% which is down from the original offer of a 12.29% increase. The medical and pharmacy plans would remain the same causing no disruption for participating NISD employees.

Increase equals \$5.45M annually/continue 70/30 split (Monthly cost to EE ranges from \$7.07 to \$30.26 depending on plan choice)

TASB provides a service that regularly reviews Board policies and makes recommendations. During a recent review by TASB and through consultation with our attorneys a recommendation was made to make minor changes in the language in policy DEC (Local) related to Temporary Disability Leave described on page 4. Temporary Disability Leave provides job protection to employees who cannot work for an extended period of time due to a medical disability of a temporary nature. The suggested change was to remove language referencing a 12 month rolling measurement time frame. There are two attachments to this agenda item, the first of which shows just the suggested changes for page 4. Also attached is the full 6 page policy for your reference. This matter was brought to the Policy Committee earlier this month.

Texas Education Code Section 11.052(i) requires a school board to re-divide single member districts "if the census data indicates that the population of the most populous district exceeds the population of the least populous district by more than 10 percent." The data collected from the 2020 U.S. census was released in mid-August 2021 and based on the results of that data, it will require the District to redraw your single member districts.

5% Differential

Population has to be within 10% of each other

As of 2020 Now 77% differential

Redistricting completed by January worst case. Would like to be done by Fall October/November.

1 person 1 vote:

- SMDs must be drawn with substantially equal population
- Exact equality of population not required (ideal district population)
- · Avoid overpopulated and under populated districts
