MORNING ARRIVAL

- The first bell rings at 8:50 am
- The tardy bell for 1st period rings at 9:00 am.
- Breakfast lines close at 8:50 am.
- If you arrive to class after 9:10 am, you are counted **ABSENT.**

ATTENDANCE

- If a student is more than 10 minutes late to 1st period, or more than 5 minutes late to any other period, they are **absent**.
- The bell to be in class 1st period is 9:00 am.

Attendance has always been important, but in high school it takes on added significance...

Excessive Absences can result in:

- 1. Losing Credit and not graduating on time
and/or**
- 2. Having to go to Court, paying a fine, and being monitored by the court.**

ATTENDANCE

90% Rule

- The state of Texas requires all students to be present 90% of the time in order for credit to be awarded.
 - No more than 7 absences for Sem 1
 - No more than 10 absences for Sem 2
- All **UNEXCUSED** and **EXCUSED** absences **COUNT** as absences

ATTENDANCE RECOVERY

75% Rule

- The state of Texas requires all students to be present 75% of the time in order to be eligible for Attendance Recovery
- Attendance Recovery will be In-Person; Not online
 - No more than 18 absences for Sem 1
 - No more than 25 absences for Sem 2

Attendance will also affect..

- Homecoming and PROM
 - Excessive absences will prevent you from attending HOCO/PROM



MEDICAL APPOINTMENTS

- If a student is out for a medical appointment, a doctor's note needs to be provided to the attendance office.
- For a student who has an appointment with a healthcare professional during school hours and submits a note to the attendance office, the classes missed will not be considered an absence.
- Must attend partial day on the day of appointment

ATTENDANCE OFFICE

VOE Forms

(Verification of Enrollment)

- VOE need for learner's permit/driver's license.
- Requirements for VOE:
 - Must have received credit for each class the semester prior.
 - Must have been in attendance 90% of the time for each class the semester prior.
 - Must be currently enrolled at Warren/CCA
- If a student meets all requirements request for VOE must be made by scanning QR code (located in the Attendance Office) 24 hours in advance. VOE can be picked up before school or during student's lunch period.
- VOEs are only good for 30 days, so make sure you have an appointment with DPS before requesting the VOE.

TARDIES

Warren/CCA HS Tardy Policy

Tardies are cumulative and will reset the next month

1st-6th Tardy	Student Warning/Parent Call
7th Tardy	Lunch Detention
8th Tardy	Two Lunch Detention
9th Tardy	ISS
10th Tardy	Overnight Suspension <i>(Parent Conference required)</i>

Students are to report to the nearest Tardy Station if they are tardy.

Tardy Stations are located: Tardy Booth (by Cafeteria), CCA Office, and Attendance Office.



CAFETERIA/LUNCH

- Students may **ONLY** eat lunch in the cafeteria or the patio/courtyard. **NO WHERE ELSE!** Not the B Building, in front of the school, auditorium, or by the portables.
- Students may utilize the Library when finished with their lunch.
 - Check with Librarians for policy on using the Library
- **DISTRICT POLICY: NO DELIVERIES are allowed!**
- Only Juniors and Seniors have Off-Campus Lunch Privileges.

OFF CAMPUS LUNCH

- Juniors and Seniors who have filled out an off-campus lunch application & the application is approved will receive a sticker. The sticker on your student ID will allow you to go off campus for lunch.
- If you do not have a sticker on the student ID, you will not be allowed off campus.
- Off campus lunch privilege will be revoked if a student has excessive tardies/absences, failing grades, or discipline infractions.
- Food is not to be consumed in the classroom or vehicle.

OFF BLOCK STUDENTS

- Students who have Off Block **MUST** leave campus after their last class.
- Failure to comply **WILL** result in loss of Off Block.
- Students **MUST** have an Off Block sticker
- Can pick one up in the Counseling Office

SAFETY & SECURITY

- Doors are locked in each building.
- DO NOT prop open doors.
- DISTRICT POLICY: IDs MUST BE WORN AND EASILY VISIBLE AT ALL TIME WHILE ON CAMPUS!

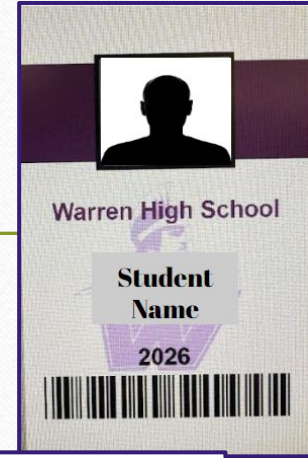

ID's/LOCKERS

ID's - Reminder: ID's must be worn
& easily visible at all times

- ID pictures can be taken during lunch or before school starting at 8:15 am. Students are not allowed to take them during class time.
- If you lose your ID, there is a \$5 replacement fee.



Mandatory Student ID Use at All High Schools:

All NISD high school students will be required to wear student IDs to better permit staff to quickly identify authorized individuals on campus. Middle schools will strongly encourage this same practice.

TRANSPORTATION



- **When the final bell rings for the day, students should make their way to the bus loop to ensure they do not miss their bus. Buses releases at 4:30 pm.**
- **Students must ride their assigned bus as designated by NISD transportation.**
- **Students on a bus must adhere to all of the rules written in the Student Code of Conduct. Bus riding privileges can be revoked. Buses are monitored by video/audio.**
- **Students must be at the bus loop while waiting for their bus.**
- **Students must remain behind the rail until all buses come to a complete stop.**

PARKING PERMITS

- Where do you purchase a parking permit? APO (A105)
- What you must have:
 - A completed Parking Permit Application; must have parent signature
 - *Provide proof of insurance with the student's name listed as a covered driver on the policy*
 - Must have a valid driver's license
 - \$20 per vehicle
- The transfer of parking permits from one vehicle to another is strictly prohibited.
- Parking permit must be visible and affixed to the vehicle's windshield. (by admin)
- Student is responsible for anyone or anything in their car.
- Parking privileges may be revoked at the discretion of administration without refund.
- Vehicles without a valid permit will be fined or towed.

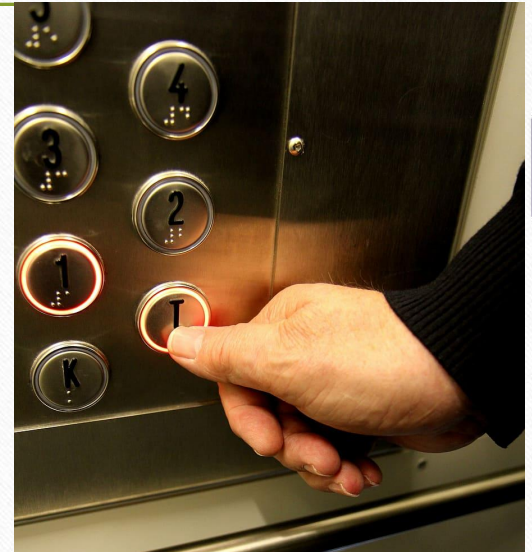
SKATEBOARDS

- Skateboards are **NOT** allowed on campus.
- **NO** skateboards will be allowed to be carried.

- Failure to comply will result in disciplinary action & confiscation of item.

WARRIORS

- Crop Tops, spaghetti straps, midriff tops or tops that are too revealing will be prohibited.
- Shorts and skirts must not be shorter than 4 inches above the knee.
- Biker shorts will not be allowed
- Jeans are not to have large holes above the knees.

At WHS we recognize the importance of individuality with regard to dress; however, the learning environment needs to be free of disruptions and distractions that dress code violations cause.

Students will be expected to follow the dress code guidelines set forth by the district. In an effort to promote a safe and positive school environment which is conducive to learning, our Warriors should wear APPROPRIATE clothing that will not cause disruptions in learning or safety.

The dress code will be strictly enforced. The administration of the school has final authority on all matters relating to the dress code. All students violating the dress code may be given clothing to change into or be given the opportunity to request clothing from home from their guardian.

Students violating the dress code will be issued a consequence. Repeat dress code offenders are subject to further disciplinary action.

Earl Warren High School & Construction Careers Academy Dress Code

Students shall be dressed and groomed in a manner that is clean, neat, and shall not be disruptive or a safety hazard to themselves or others. The items below are not all-inclusive. Please refer to the district handbook for additional information. Final determination of acceptable dress and grooming rests with the campus administration.

No excessively ripped jeans above mid thigh



Skirt/dress/short length must be mid thigh or longer



No hoods or sunglasses allowed in the building



No biker shorts or sagging pants are allowed



No muscle shirts or inappropriate graphics or language on clothing



No see through, strapless, low cut, midriffs, spaghetti strap or racer back shirts allowed



WARRIOR DRESS CODE: WHAT NOT TO WEAR

Shorts, skirts, or dresses that are shorter than mid thigh.

Ripped jeans with excessive rips or tears that are above mid thigh.



WARRIOR DRESS CODE: WHAT NOT TO WEAR

WARRIOR DRESS CODE: WHAT NOT TO WEAR



Halter tops, tube tops, midriiffs/crop tops, low-cut, exposed back, tank tops, muscles shirts, spaghetti straps or see through garments.



WARRIOR DRESS CODE: WHAT NOT TO WEAR

Inappropriate graphics on clothing or any personal items.

For safety reasons, hoods will not be worn in the building.

NO VAPING

WITHIN 300 FEET OF A SCHOOL CAMPUS

HB 114, enacted by the Texas Legislature (2023), requires school districts to implement mandatory Disciplinary Alternative Education Program (DAEP) placement for students found in possession of, using, selling, giving, or delivering e-cigarettes or vaping devices on school grounds or at a school-related event.

DRUGS

- Anything consumed that changes/alters your mental/physical state
- In possession of...you are responsible for: person, locker, bag, car, etc...
- You can get arrested
- Criminal & school consequences
- DAEP/JJA placements

LEGAL CONSEQUENCES

- In Texas, it is a **FELONY** offense if a person is caught using or in possession of a THC pen with any amounts of Dab or THC oil. (HSC 481.116)
- An edible is weighed and the weight determines the degree of the felony.
- Up to a \$10,000 fine.



SCHOOL CONSEQUENCES

A student SHALL BE EXPELLED from the school if the student is on school property, on school property of another district, at any district facility, at any school sponsored or school-related activity on or off of school property, or on a school bus;

(c) sells, gives, delivers to another person or possesses or uses or is under the influence of :

(1) Marijuana if the conduct is punishable as a felony

EXPULSION

- **Removed from all Northside ISD schools**
- **Student must enroll into the Juvenile Justice Academy (JJA)**
- **JJA is run by the Bexar County Sheriff's Department**
- **JJA only offers Math, Social Studies, Science, English, and PE which can result in a student falling behind on credits required for graduation**
- **Up to a calendar year**
